ELIGIBILITY REQUIREMENTS

You must not be a candidate for public office and must agree not to become one until after one (1) year after the initial exhibition of the episodes of the Program in which you appear, if selected as a participant.

All eligibility determinations shall be made solely by Wallin Chambers Entertainment (“Producer”) in its sole discretion and are final and binding in all respects. Producer reserves the right to add to or modify the eligibility requirements at any time.
