ELIGIBILITY REQUIREMENTS

Please be advised that you must meet the following eligibility requirements in order to be considered to participate in the television project currently entitled “Unscripted Courtroom Docu-Series” (the “Program”):

- You must be at least 21 years of age (or the age of majority in your state of domicile, if older) as of the date this application is submitted.
- You must be legally authorized to live and work in the United States on the Program, or you are in the process of attempting to obtain lawful authorization so that you will be able to legally live and work in the United States on the Program by the time pre-production begins on or around 2023.
- You are not currently, nor do you currently intend to be, a candidate for public office, and if there is any change in this representation prior to the initial exhibition of the Program in which you appear, you must immediately notify NBCUniversal (as defined below) at ReportingCandidacy@nbcuni.com. Becoming a candidate before or around the time of the initial exhibition of the Program may under certain circumstances have legal implications on the exhibitor's ability to exhibit the Program.
- You agree that your submission of this application and your participation does not run afoul of any judicial or attorney rules of professional responsibility or conduct.
- All eligibility determinations shall be made by Wallin Chambers Entertainment, LLC (“Producer”) (as defined below) in its sole discretion and are final and binding in all respects. Producer reserves the right to add to or modify the eligibility requirements at any time. Further Producer (as defined below) reserve the right to render ineligible any person who either of them determines, in their sole discretion, is sufficiently connected with Producer and/or the development, production, administration, judging, exhibition, distribution or other exploitation of the Program, such that his/her participation in the Program could create the appearance of impropriety.
